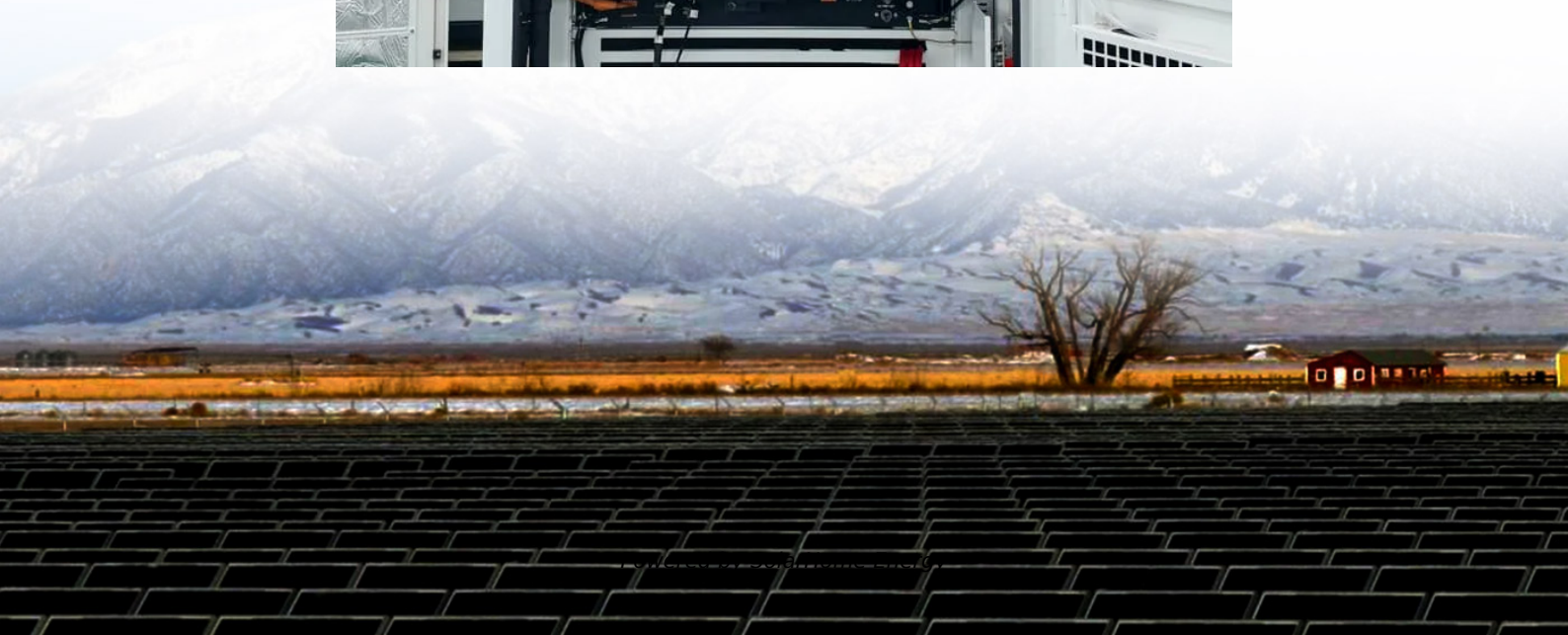


Cambodia Energy Storage System Export Tariff





Overview

How will US tariffs affect Cambodia?

Cambodia, facing a staggering 49% tariff on its U.S. exports, stands among the most severely impacted nations. A subsequent announcement on April 9th provided a 90-day window for negotiations, potentially allowing countries to adjust their tariff rates. An interim tariff was established, with specific rates for certain categories and countries.

What is the standard tariff rate for Cambodia?

The standard 19% tariff rate for Cambodia may be subject to exceptions or modifications under various trade agreements.

In Cambodia, commodities are classified using the Harmonized System (HS Code) which is compliant with the ASEAN Harmonized Tariff Nomenclature (AHTN).

When importing goods from Cambodia subject to the 19% tariff rate, businesses must ensure proper compliance with customs regulations.

What is a new tariff agreement between US and Cambodia?

In a significant development for regional trade and economic cooperation, the United States and Cambodia have concluded a new tariff agreement that sets a unified tariff rate of 19% on a range of Cambodian exports to the US effective 1 August 2025.

What are tariffs & how do they affect US imports?



Tariffs are taxes imposed on imported goods and services. Currently, the tariff rate for 19% applies to imports from Cambodia. This represents additional costs that importers pay when bringing goods into the United States from Cambodia. Furthermore, this rate can change based on trade agreements, economic conditions, and government policies.
