

Energy storage equipment subsidies





Overview

All residential storage systems over 3 kilowatt-hours (kWh) in size are eligible for the 30% tax credit when purchased and installed by the end of this year. For a typical home energy storage system, the ITC can reduce the cost of your system by \$3,000 to \$5,000. What is the energy storage credit?

Can receive a bonus for domestic-sourcing of materials and for siting projects in "energy communities". The Energy Storage Credit adds a new provision to the energy investment tax credit for energy storage, including hydrogen storage, available through 2025 before a transition to the Clean Energy Investment Credit.

Will state aid be available for large-scale electricity storage systems?

In autumn 2024 two draft regulations were published regarding state aid for large-scale electricity storage systems (BESS), one from the Modernisation Fund ("MF ") 1 - and the second under the National Recovery and Resilience Plan ("RRP ") 2.

What is G11.3 energy storage systems?

The "G1.1.3 Energy Storage Systems" programme is being developed to support lithium-ion technology for energy storage and power off-take facilities connected to the national grid. According to the Draft RRP Regulation:

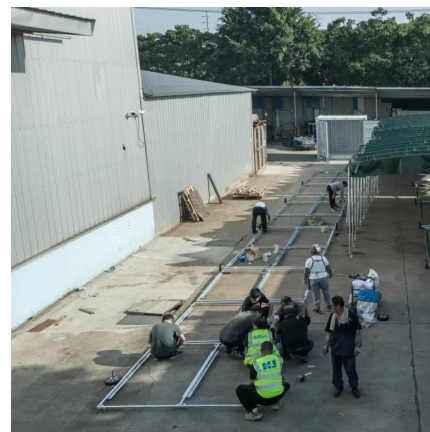

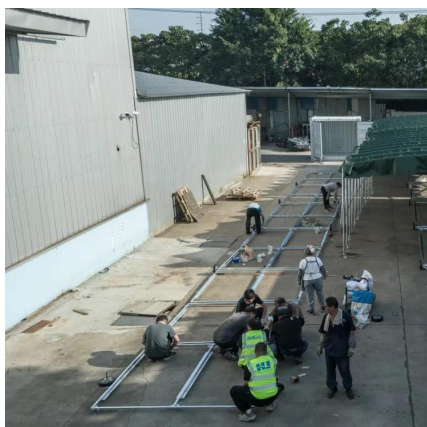

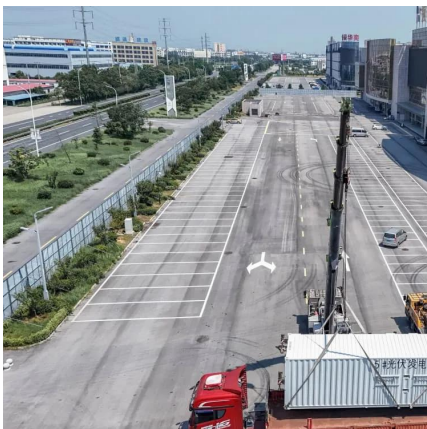
