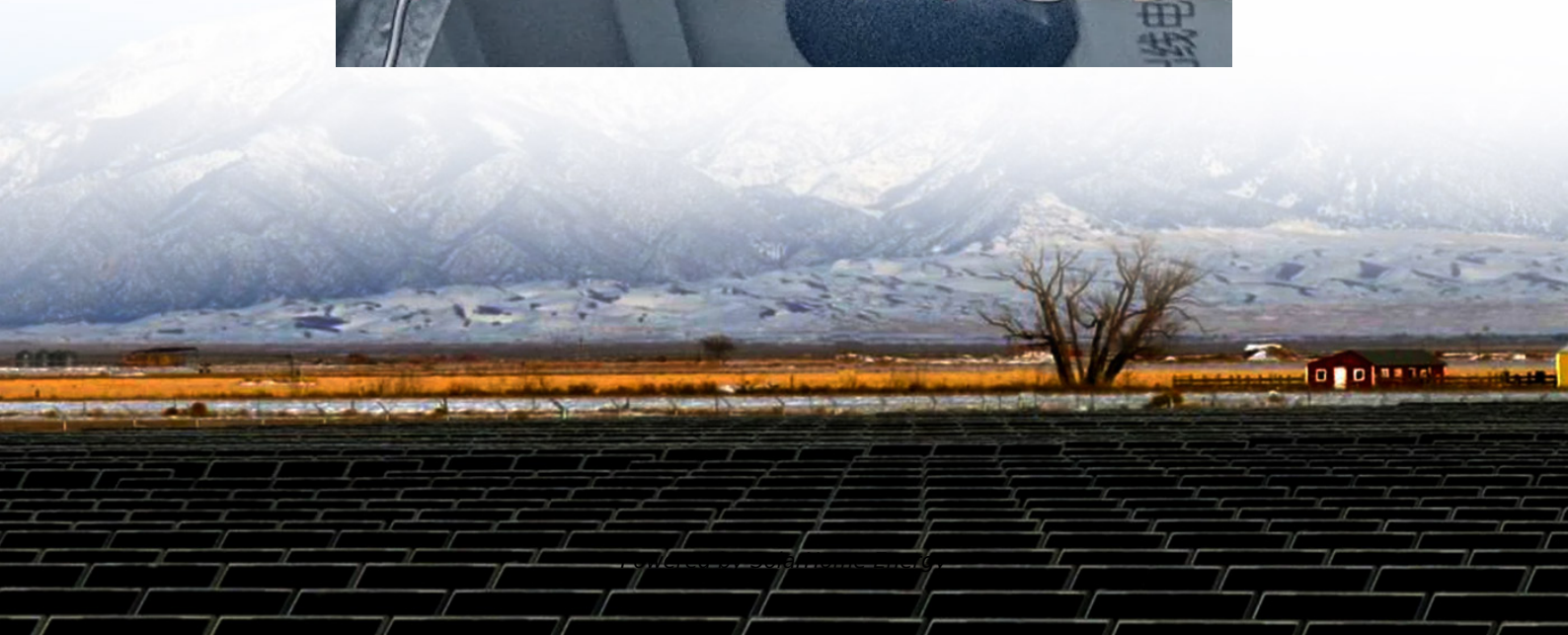


Saint Kitts and Nevis uses outdoor energy storage power



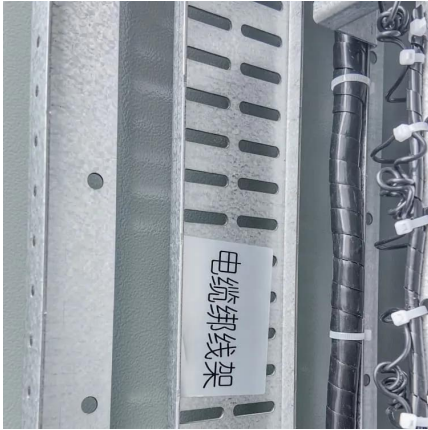


Overview
