all transfers of property, other than real property, located in Vanuatu; all transactions and declarations in respect of shares, debentures or other securities of the company; and all other transactions relating to the company's business.

Does Vanuatu have a tax certificate?

While Vanuatu offers a tax certificate to verify residency, the absence of income tax means there are no tax returns to demonstrate tax payments. This makes the option more attractive to perpetual travelers but less ideal for those living a "trifecta lifestyle" across multiple countries.


